# Treasurer Report

The role of the CPHA Treasurer is to support the financial management of the organization by providing oversight and review of monthly financial statements, approving expense and reimbursement requests, providing budgetary support to committees, and supporting long term planning for the financial health of the organization. In 2019, several key successes were accomplished, including:

- Leadership of the finance committee and facilitation and documentation of committee goals and objectives;
- Updating finance committee and treasurer roles and responsibilities in the CPHA bylaws;
- Implementation of updated and standardized budgeting, expense, and reimbursement forms for board member and committee utilization; and
- Planning for the creation of a Resource Development Plan to accompany the CPHA Strategic Plan.

Looking ahead, as we prepare to finalize and implement the CPHA Strategic Plan, the finance committee will be working to identify and align financial goals and document our business plan and strategies for revenue diversification in an overarching Resource Development Plan. We welcome individuals with experience and/or enthusiasm to support CPHA in articulating our financial goals- please consider joining our committee!

Below, we provide the 2018 financial data, comparing budget to actual income and expenses. We finished the 2018 year with a net profit of \$87,900, largely due to a successful 2018 Public Health in the Rockies conference.

# Membership Report

The membership team has worked hard this year on several strategic goals. We were somewhat slow to get up and off the ground since the director position and committee was dormant in 2017 and 2018. Though membership numbers are down slightly from 737 to 720 we are positive about future growth. In order to better coordinate and align efforts we have combined the communication and membership committees and attendance is steadily growing. Early in 2019 the board created a strategic plan. There are 2 goals in the plan that directly relate to membership:

**1) Increase current membership so that CPHA's board and membership are reflective of Colorado's public health workforce.**

**2) Expand access to the use of professional development & education for the current and future public health workforce so that all members have a variety of ongoing growth opportunities to engage at individually meaningful levels.**

The board has spent much time discussing the strength of our organization, what resources we have to utilize, and how we can best serve the community. These two goals are reflective of where we believe the membership/communication committee can best focus and take some action steps.

The Membership and Communication Committees have also helped to put together several networking and educational events to date including: snowshoeing outside of Boulder in March and a tour of Denver's River North neighborhood focusing on its history and gentrification. There was also a large turnout for our annual Public Health Advocacy Talks (PHAT).



The Colorado Public Health Mentoring Program (CPHMP), a great asset to many, and is a program the CPHA Board and its members need to provide additional support. For several years in a row we have a significant gap in the number of mentees and mentors creating a situation where we have to turn away eager young professionals. Strong advocates of the program were able to recruit new mentors this year but help is needed to help sustain the program. Mentors who have completed the program say they learn so much more from the experience than expected and often return to do it again the next year.

A membership survey will be conducted at the CPHA booth at the 2019 PHIR. This survey aims to better understand what offerings are helpful and which are not, and what expectations might not be being met. New ideas for events and educational material are always appreciated. Please, consider taking time to complete the survey if you have not already.



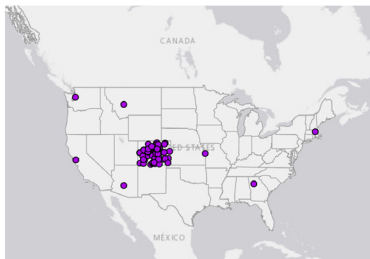

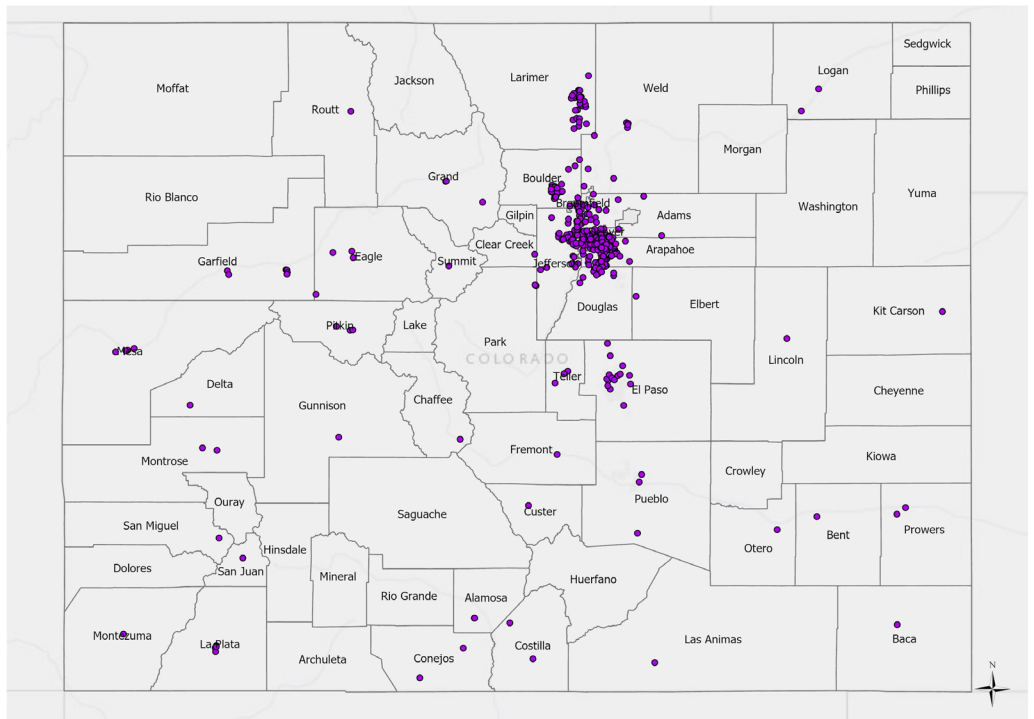

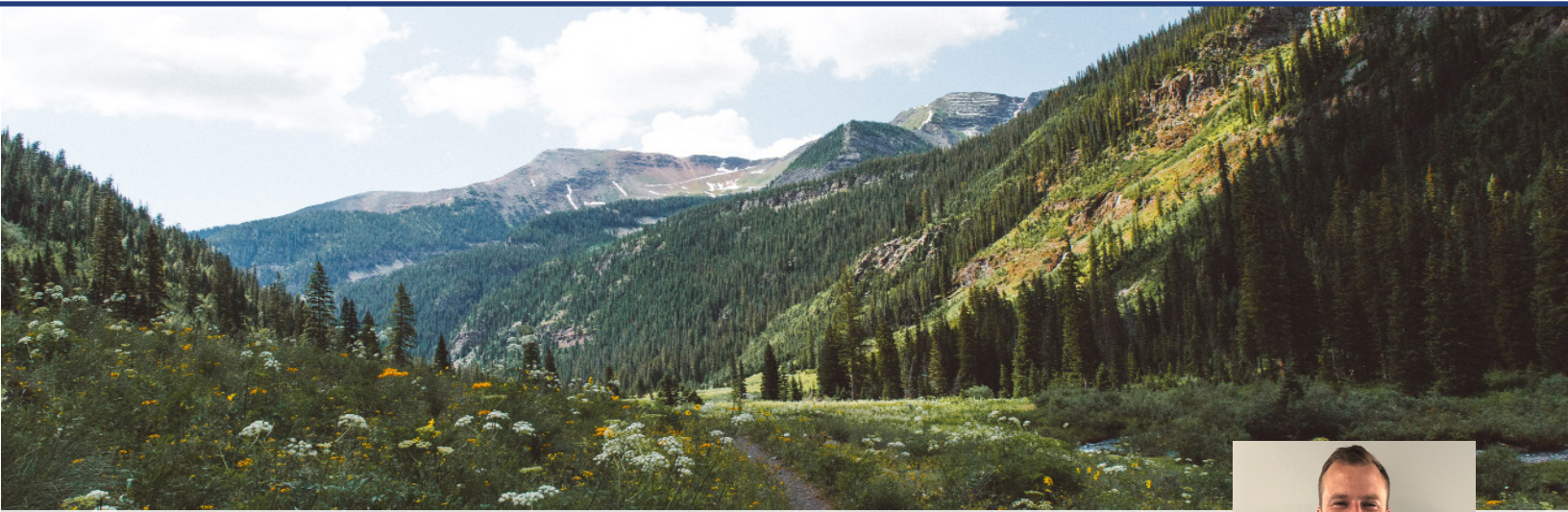

# Communications Report

The CPHA communications committee has actively pursued many goals over the past year including: maintaining the momentum of membership engagement, continued growth in social media presence, strong coordination with all committees, commitment to policy campaigns, and quality event promotions. The breadth of communications activities necessitated sustained efforts in many avenues of CPHA work and to this end the communications director has been actively involved in multiple committees including Public Health in the Rockies, Culture of Data, Public Health Advocacy Talks, and Health Equity. Coordination with the membership committee resulted in the merging of the communications and membership committees to meet at the same time monthly. Aside from solid social media growth, the communications director was actively involved with the policy directors during a very busy legislative session that included CPHA supported positions on 35 bills. Strategic planning in conjunction with the Health Equity Committee was also a success this year with a series of feedback sessions that resulted in equity driven strategies and tasks for the coming year. We look forward to the prospects for continued growth and opportunities to move the presence of CPHA forward in all aspects of our work with an equity informed perspective.



- **Consistent outreach during a busy legislative session via member action alerts related to the 35 CPHA supported bills.**
- **In the past year, CPHA's Facebook likes (1,146) have increased exponentially and weekly engagement is consistently high with organic (non-paid) post reach often topping 450. Strong growth on instagram was also a highlight with 1,040 followers and a successful photo challenge during National Public Health Week that included submissions from around the state.**
- **Strategic planning in conjunction with the Health Equity Coalition resulted in a communications plan that will lay the foundation for equity informed work moving forward.**







# Health Equity Report

The CPHA Health Equity Coalition is comprised of over 100 individuals from diverse personal and professional backgrounds who envision a Colorado where “all will have the opportunities essential to attaining their highest level of health.” We strive to achieve this vision through a commitment to difficult conversations, unity across struggles, education, community engagement, advocacy, leadership development, status quo disruption, and personal and societal transformation (with happy hours in between). The coalition has 3 work groups (Professional Development and Education, Organizational Infrastructure and Community Outreach and Engagement) that have achieved much in the past year. Here are some highlights:

## **Professional Development and Education**

- Developed a comprehensive list of statewide equity-focused organizations and initiatives for education and dissemination
- Provided education for the Rocky Mountain Public Health Training Center’s Health Equity Learning Cohort, Public Health

## **Advocacy Talks and the ECHO Colorado Health Equity Online Learning Series**

- Hosted monthly Health Equity Webinars
- Solicited and implemented input on priority areas of equity related learning for PHiR
- Partnered with the Center for Health Progress and other organizations to host “Waiting for Health Equity” discussions

## **Organizational Infrastructure**

- Worked closely with CPHA Executive Committee and Board of Directors to infuse and implement health equity into CPHA infrastructure, strategic work plan, communications and bylaws
- Presented equity coalition model guidance at APHA conference and to APHA Council of Affiliate Leadership
- Ensured HEC representation and collaboration with other CPHA Committees including Policy, Emerging Leaders, and PHiR Planning

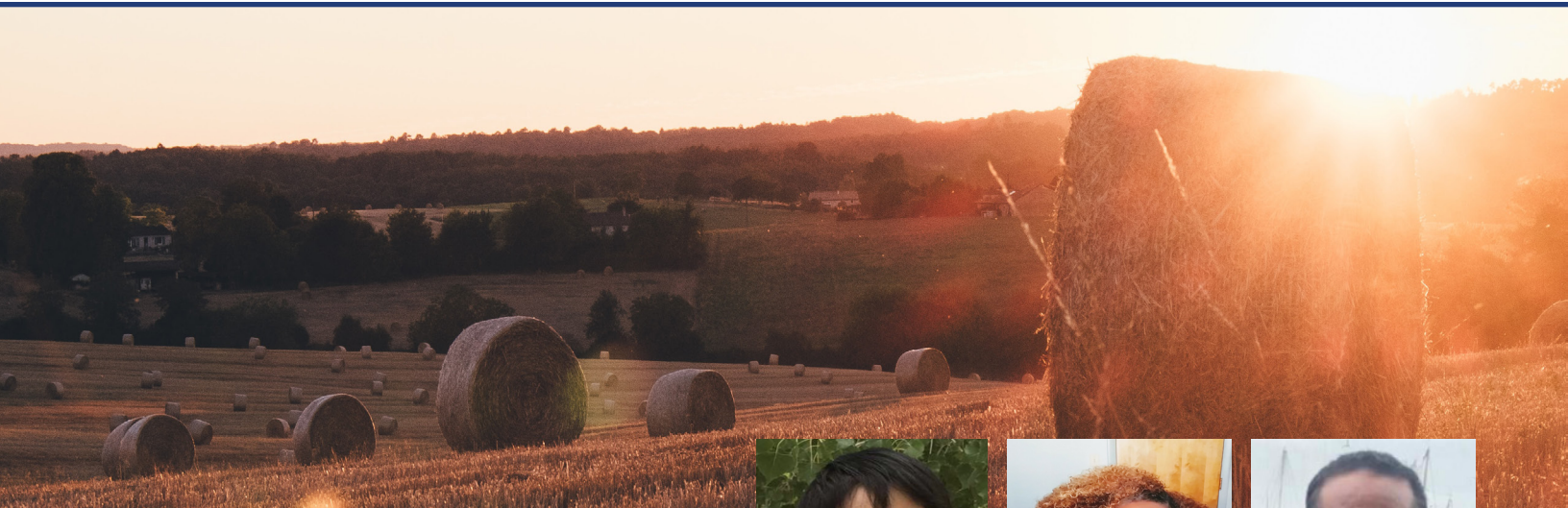
## **Community Outreach and Engagement**

# Public Health Policy Report

## Policy Update / Overview

Strengthened by the participation of diverse Policy Committee members from throughout the state and collaboration with the Health Equity Coalition, CPHA's Public Health Policy Committee actively engaged in Colorado's 2019 legislative session to address key public health and environmental health issues and social determinants of health. CPHA's public policy capacity was also bolstered this year by the addition of a Jr. Policy Director, Kaitlin Wolff, and by the advocacy of CPHA Board Member at Large, Jodi Radke on tobacco and youth smoking prevention. In January 2019 a CPHA general membership survey identified these general public health policy areas and specific policy issues as 2019 legislative priorities:

In 2019, to advance member priorities and respond to a watershed year of public health legislation, CPHA took a formal position on more than twice as many bills (35) in the 2019 state legislative session as in 2018 (16). CPHA also performed policy education by disseminating member alerts (8), presenting testimony (5), submitting published letters to the editor (1), attending educational press events (2), and participating in coalitions and signing on to group fact sheets or letters (6). Many significant public health and health equity promoting bills supported by CPHA became law this year in all member priority areas as listed on the following page.

# Affiliate Representative to the Governing Council (ARGC) Report

In addition to serving on the CPHA Board as an Executive Officer, the ARGC position represents CPHA on APHA's Governing Council alongside 53 other Affiliates from around the country. The ARGC is the connection between APHA and CPHA and holds responsibilities in that capacity, including:

- **Representing CPHA's policy agenda within APHA's Governing Council**
- **Assisting APHA, in cooperation with CPHA, with federal legislative advocacy. In 2018-19, this has included CPHA signing on to letters of support regarding:**
  - **Opposition to Proposed Cleaner Cars Rollback (letter to the EPA and NHTSA from the American Lung Association)**
  - **Funding for the Centers for Disease Control and Prevention (CDC) to conduct public health research into firearm morbidity and mortality**
  - **Funding for the Centers for Disease Control and Prevention's programs in the FY 2020 Labor, Health and Human Services, Education and Related Agencies Appropriations bill**
  - **Increase in Health Resources and Services Administration discretionary funding for primary and preventative health services**
  - **Collaborating with CPHA's President, Executive Committee, and Civica to ensure APHA's Affiliate requirements are met**
  - **Maintaining ongoing communication with ARGC's from other Affiliates on APHA's Affiliate Forum and within Region VIII**

# Emerging Leaders Report

In the 2018-2019 term, the CPHA Emerging Leaders Committee (formerly the Student Committee) has worked to expand its reach and continue elevating the voices of Colorado’s public health students and early career professionals. The Emerging Leaders Committee’s goals are to increase membership and participation in CPHA activities and to represent the voice of students and early career professionals in the organization.

This year, the Emerging Leaders Committee Directors expanded the group’s role to include a focus on leadership development. The Committee seeks to meet a growing interest among students and early career professionals who want to identify their leadership styles and strengths, and learn strategies for becoming effective leaders in public health. To achieve this, the Committee has incorporated a different leadership topic and discussion into each of its monthly Zoom meetings and connected members with relevant leadership opportunities within CPHA. This year, a few leadership opportunities that members have pursued include: running for the CPHA Board; actively participating in other CPHA groups including the Policy Committee and Health Equity Coalition; volunteering to assist with National Public Health Week events; networking with CPHA past presidents; and volunteering and presenting at Public Health in the Rockies 2019.

**A few key Emerging Leaders accomplishments in the 2018-2019 term include:**

- Developing the CPHA “Commitment to Public Health Certificate,” which allows members to demonstrate leadership in public health by contributing to various CPHA efforts
